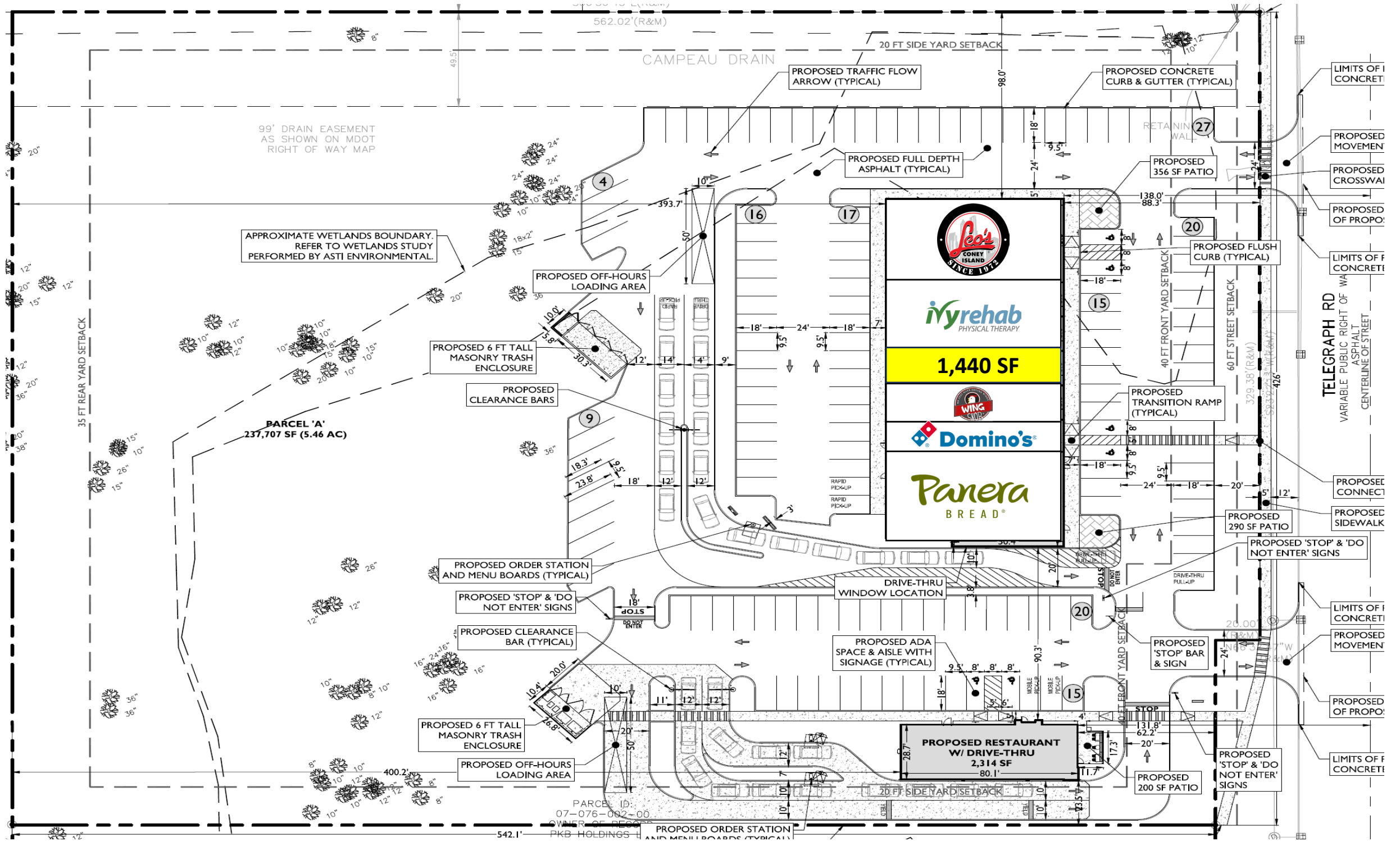

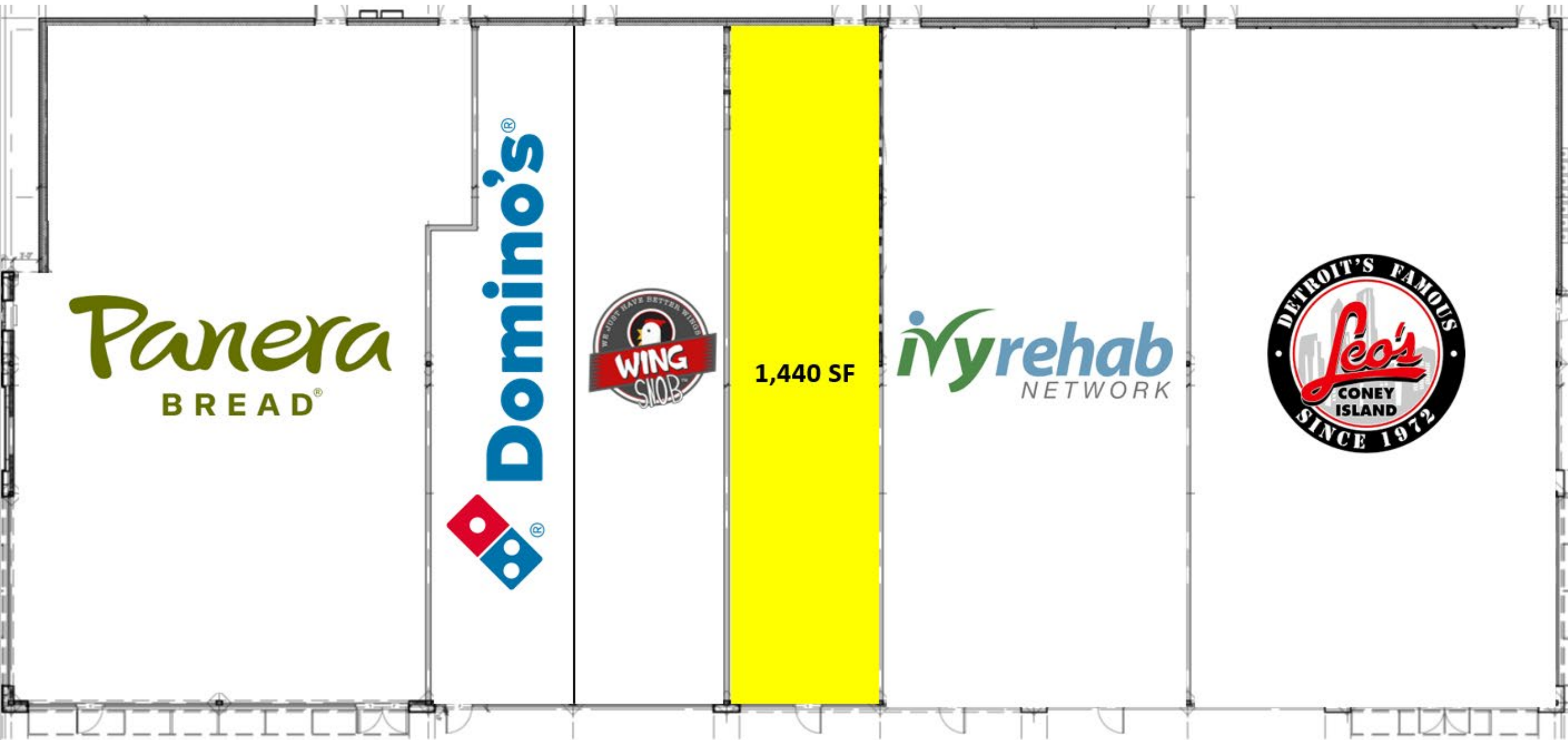


**PROPERTY HIGHLIGHTS**
