

DEMOGRAPHICS (FIVE-MILE RADIUS)




PROPERTY HIGHLIGHTS

- surrounded by national retailers such as Taco Bell, Popeyes, Tim Hortons, Wendy's and McDonald's.


This site is easily accessible with multiple curb cuts off of Dixie Highway and located within a quarter mile of I-75.

STARBUCKS DEVELOPMENT SITE PLAN














SOUTH (BACK) ELEVATION
