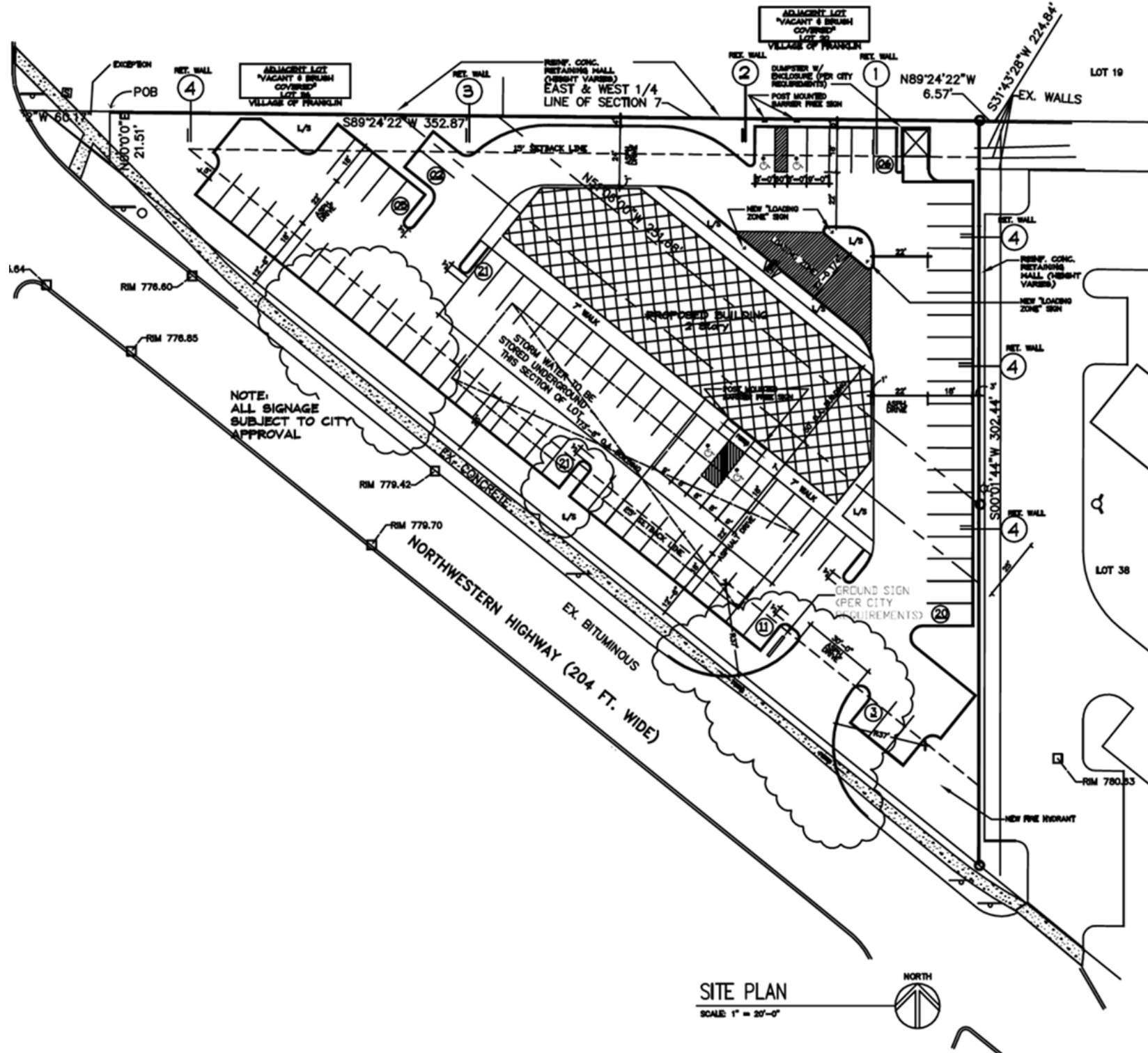

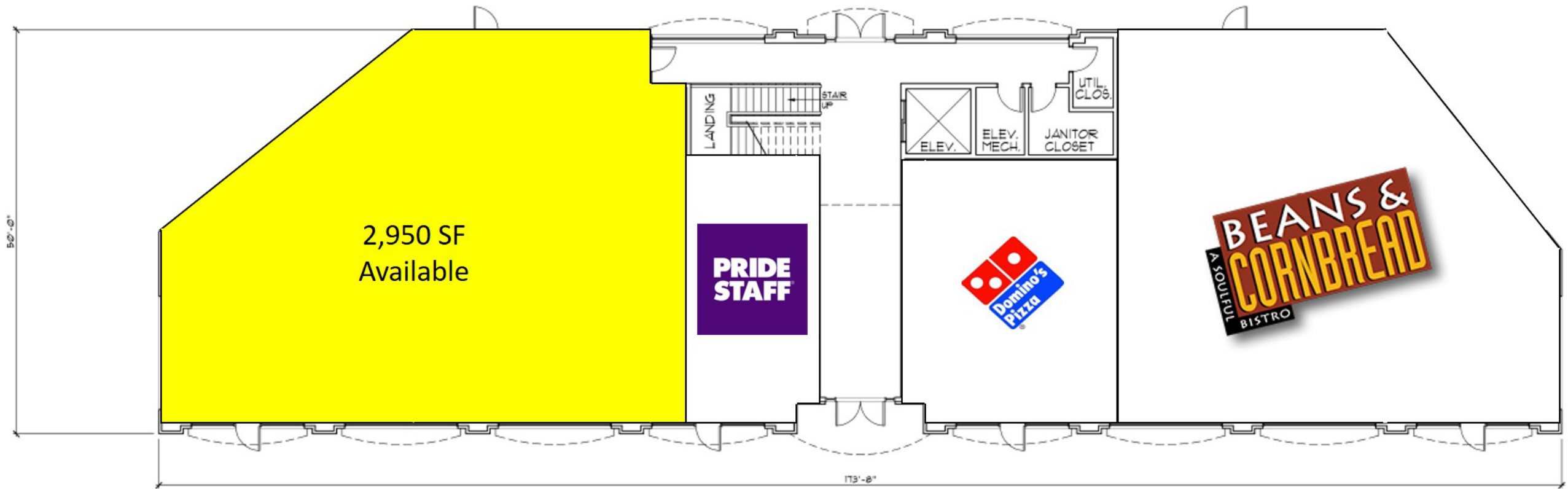


**PROPERTY HIGHLIGHTS**

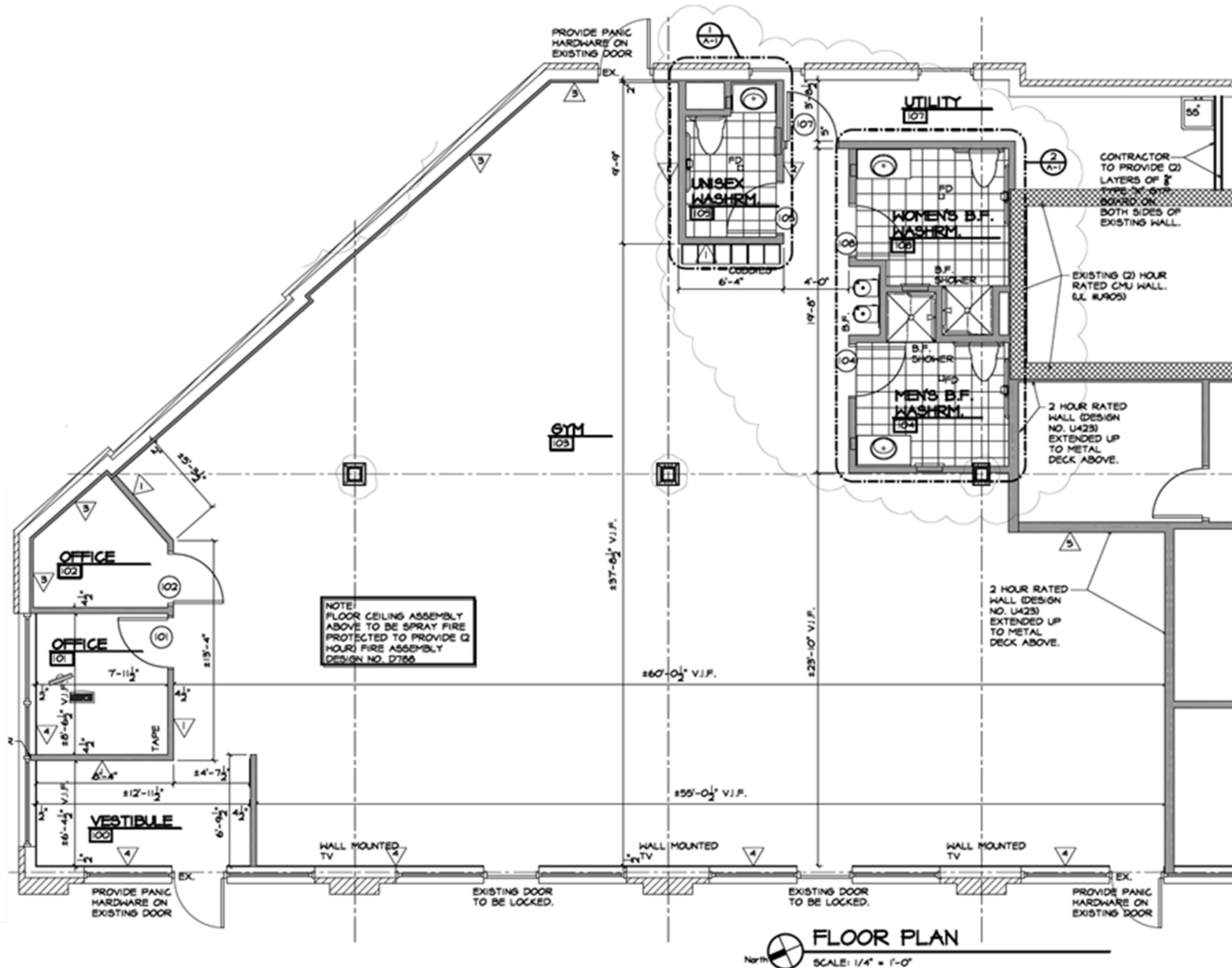


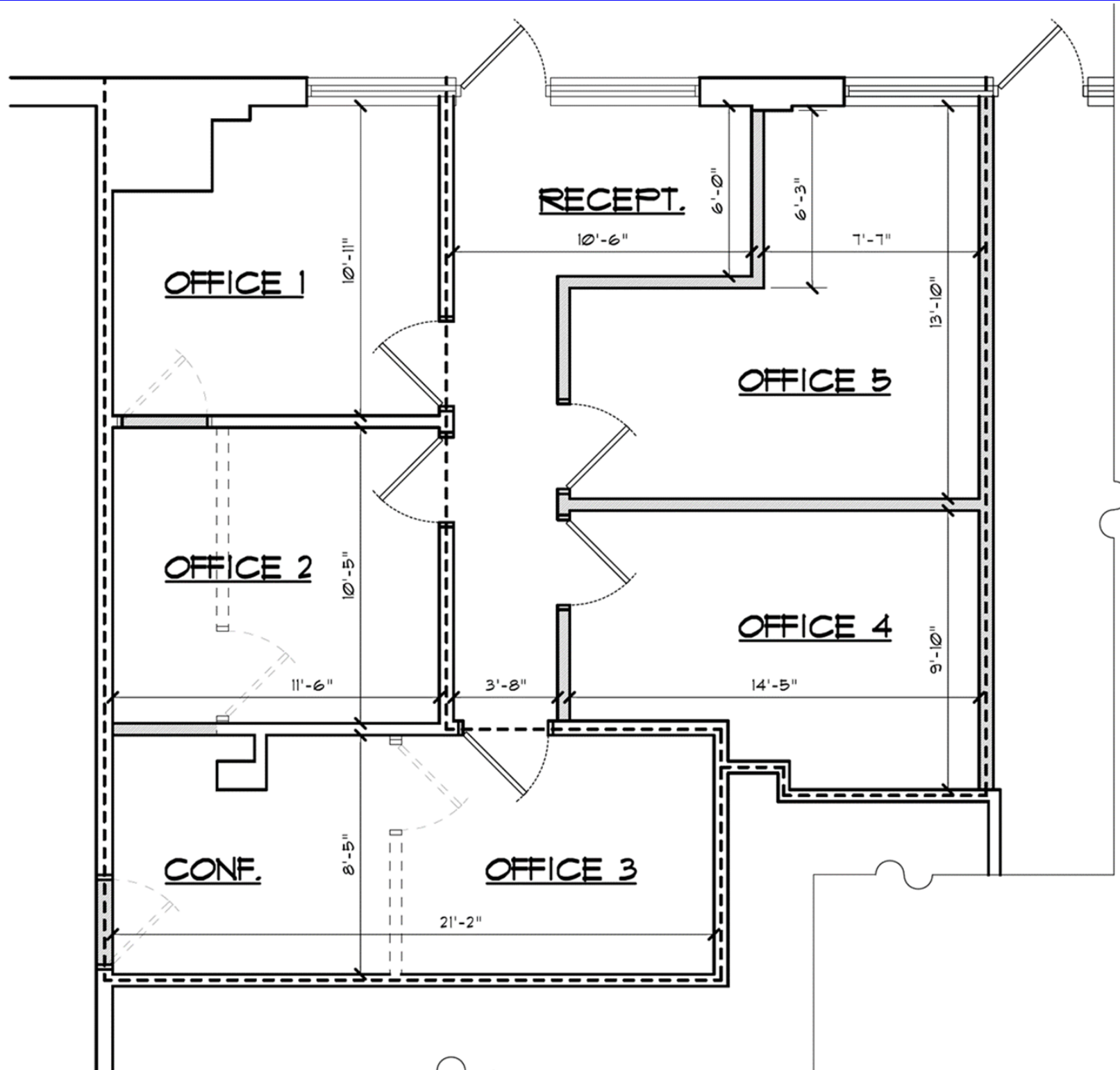
**SITE PLAN**  
SCALE 1" = 20'-0"



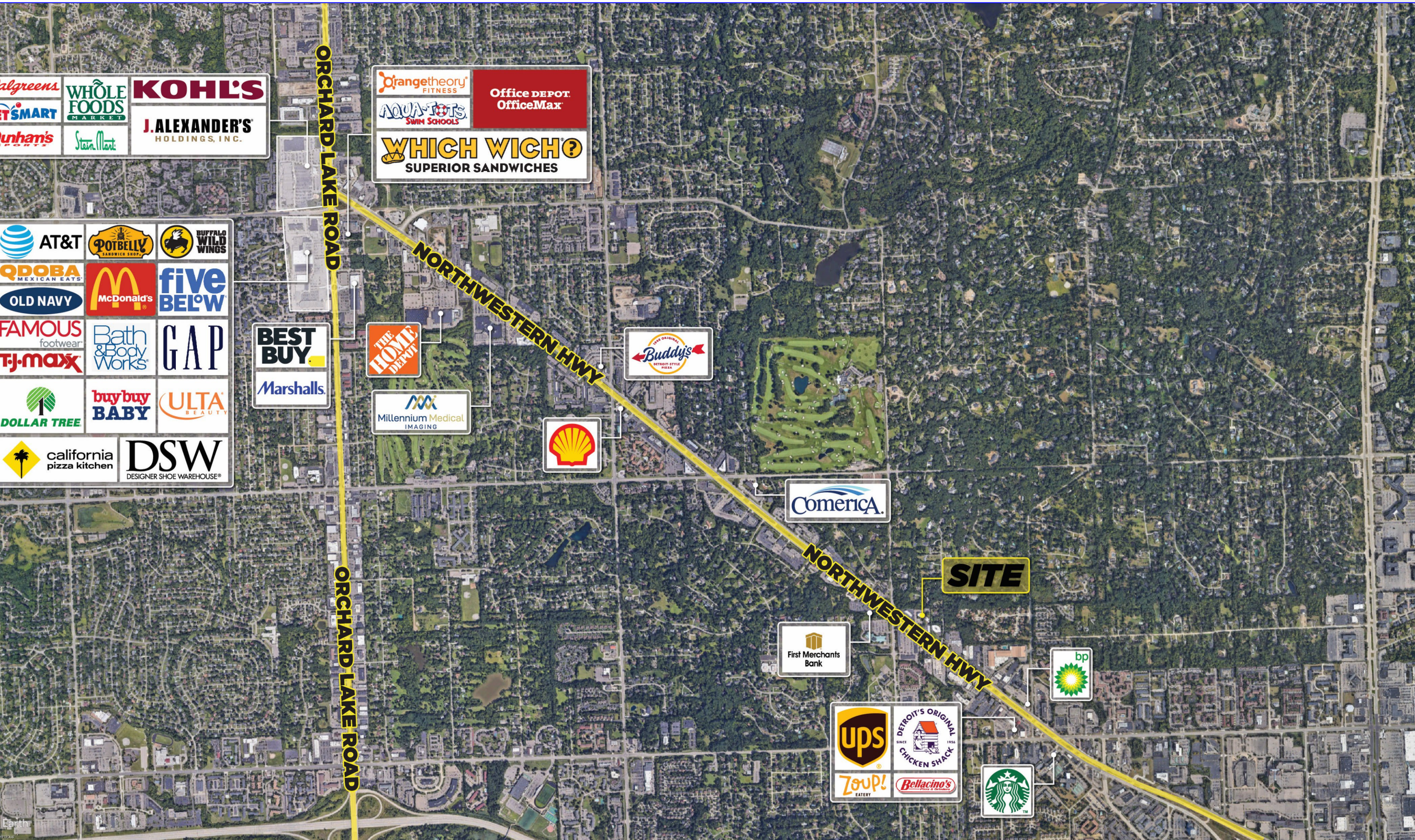
FIRST FLOOR PLAN
