


The site is situated in Sterling Heights, the second largest suburb in Metro Detroit and the fourth largest city in Michigan. This location offers a

- Not only does the site provide multiple ingress/egress points off both 14 Mile and Van Dyke, but the intersection also sees more than 65,000 VPD.



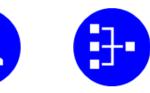
