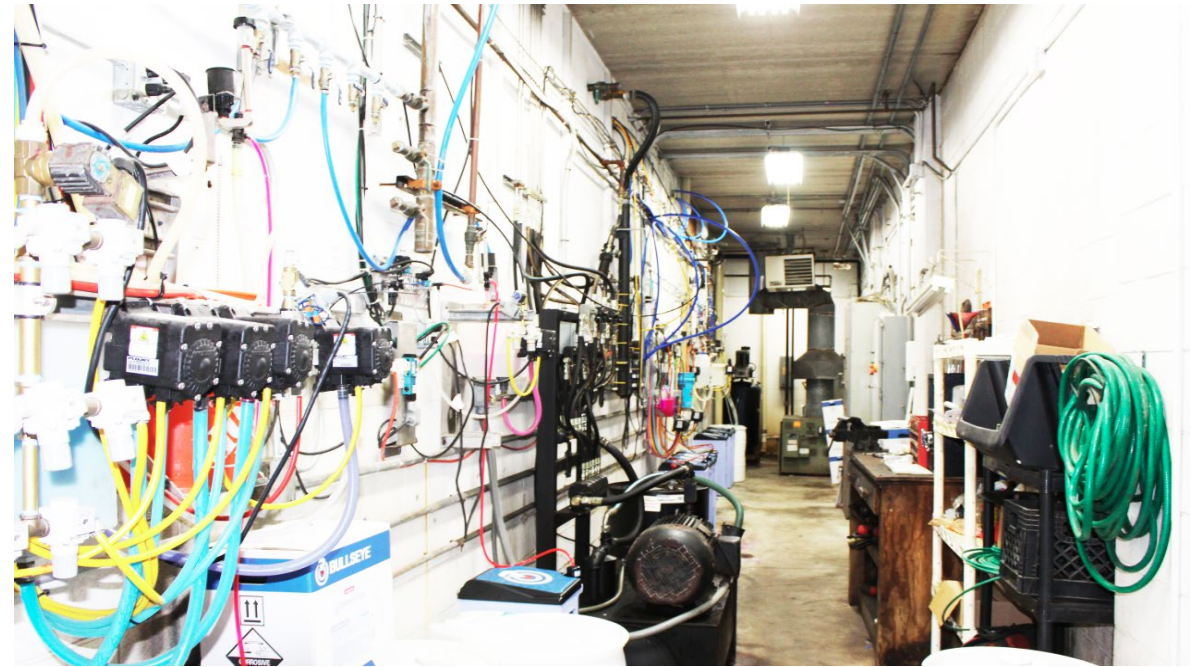

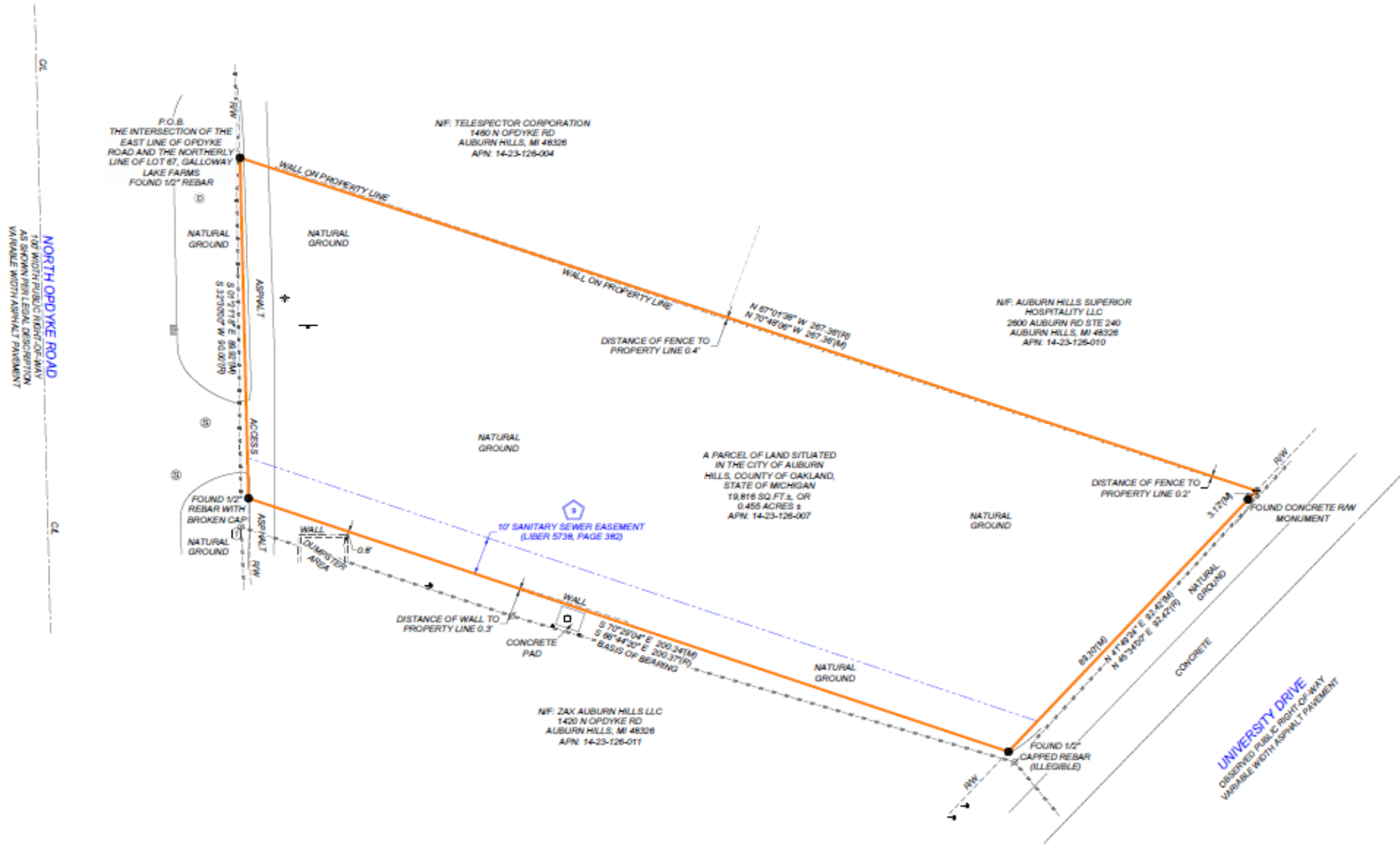


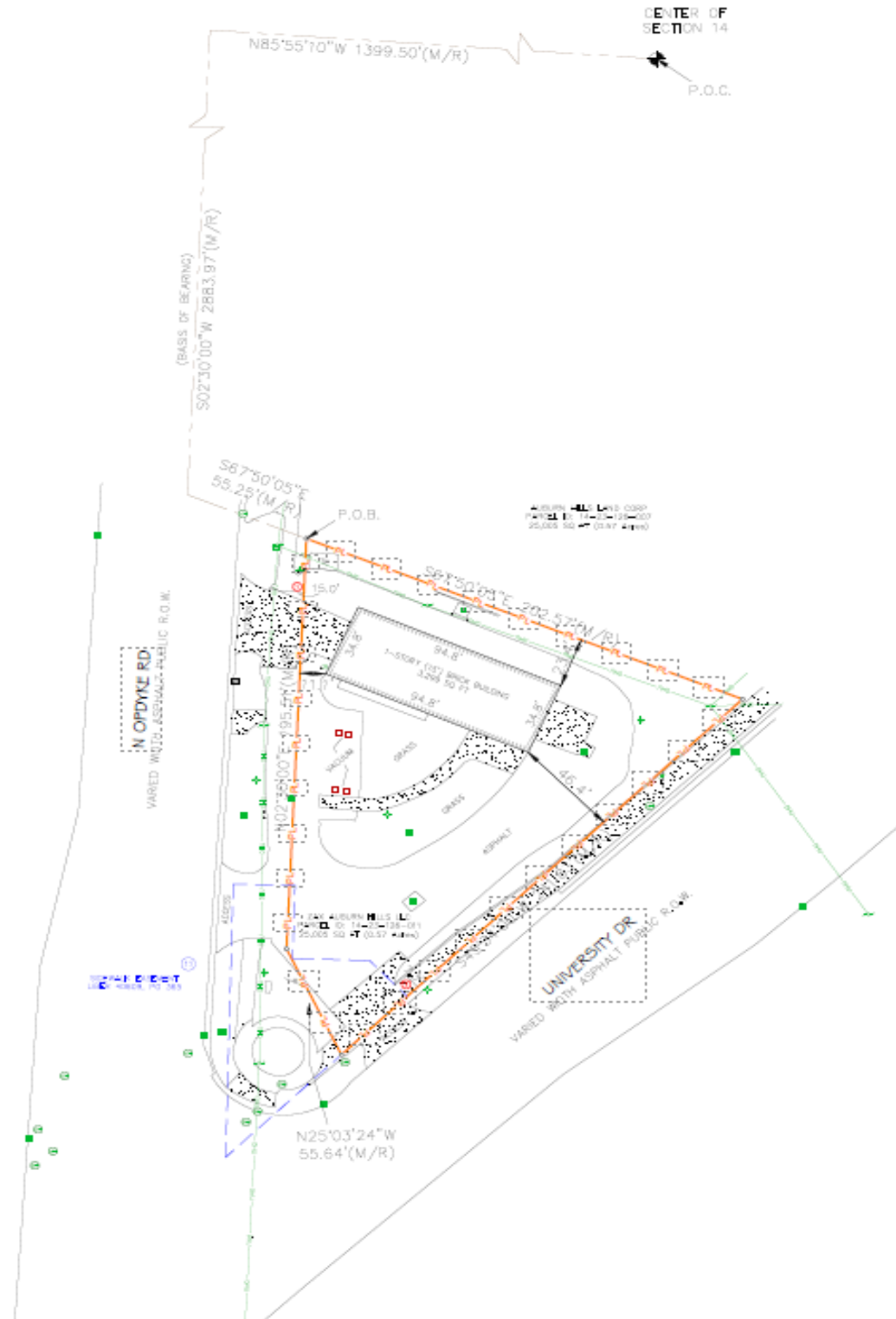
**PROPERTY HIGHLIGHTS**

- Nearly 160,000 residents within a five-mile radius, with an average household income exceeding \$98,000 annually, providing a robust customer base.

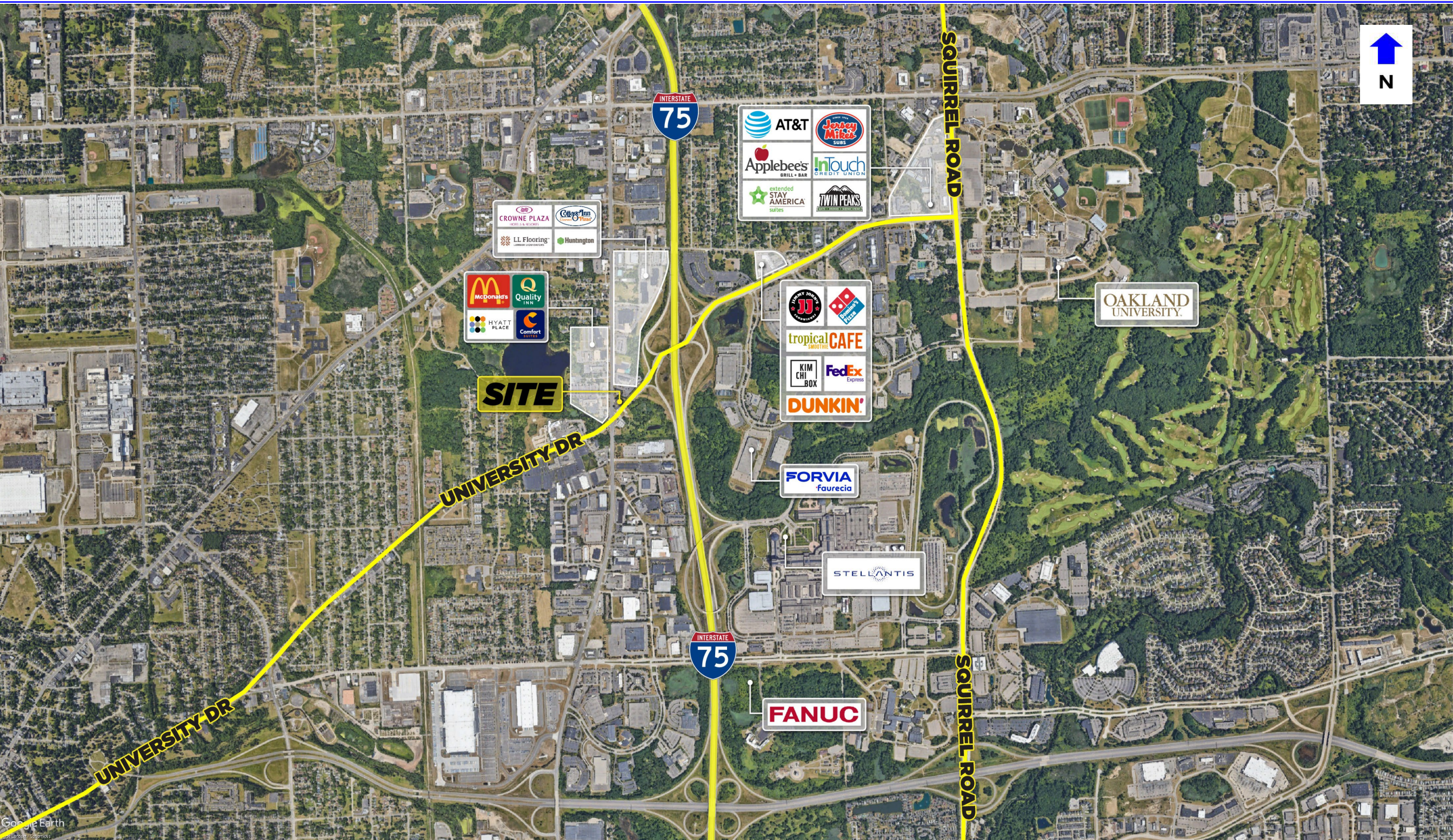
