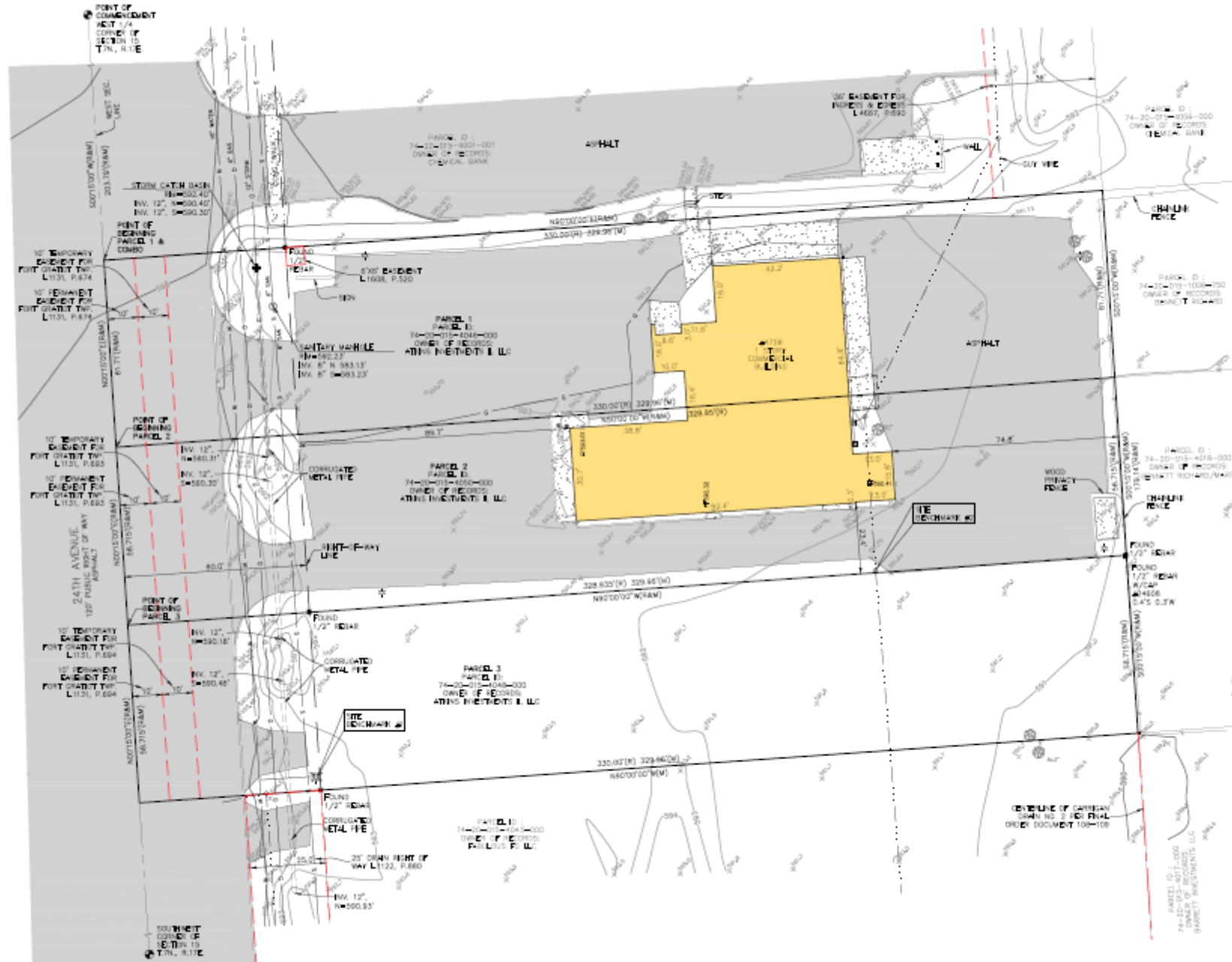
PROPERTY HIGHLIGHTS
